- 1.The main text should be in Times New Roman with font size 12 and line spacing of 1.5.
- 2.The footnotes should be in Times New Roman, font size 10 with a spacing of 1 inch margins should be maintained on all four sides.
- 3.Citation Style: Bluebook, 19th Edition.
- 4.The maximum length of the paper shall not exceed 5,000 words. (Including footnotes/endnotes/annexure/reports etc.).
- 5.All submissions are to be made in Microsoft Word (.doc) format only.

IMPORTANT NOTE

- 1.Paper Co-authorship is permitted to a maximum of two authors.
- 2.All authors need to register separately for Call for Papers. The fee for Papers, once submitted, shall be non-refundable.
